1. **Cover page:** Use the form below as the cover page for submission of the abstract. Include the title of the presentation to be listed in the conference program; the full name, address, organizational affiliation, e-mail, and telephone/fax numbers of all presenters; and a one paragraph description (30 words or less) of the presentation for the conference program.
2. **Proposal:** Prepare the proposal as a separate document than the cover page. The proposal may not be longer than two (2) pages (200-300 words). To ensure blind review, include only the full title of the paper, panel discussion, or workshop and the proposal.
3. **All proposals are blind-reviewed**
4. Proposals must be received NO LATER THAN **August 1, 2010**.
